A dean representative is elected by the Dean's Council to serve for a two-year term. Two faculty senate representatives are elected by the Faculty Senate each April for two-year staggered terms, each term beginning the day following the last official day of the spring semester and ending on the last official day of a spring semester. The NMSU Employee Council representative is elected by the council for a two-year term, beginning the day following the last official day of a spring semester and ending on the last official day of the spring semester.
